Application Procedure and Instruction

The new academic year begins in September. Applicants are asked to send the completed

Application Form before the end of July for the new academic year or before the end of December for the Spring semester that starts in February of the following year.

- 1. Applicants must send to Lanzhou University of Finance and Economics along with the completed Application Form and other materials specified above.
- 2. After receiving the application materials by the date specified above, the recruiting committee in the school will review the application materials and select applicants for further interview. The applicants selected will be notified in advance, and then we will send the applicant the Visa Application Form (JW202) and Admission Notice.
- 3. By submitting the Visa Application Form for Study in China (JW202) and Admission Notice along with the completed "Physical Examination Report for Foreigner", the admitted applicants should apply to the Chinese Embassy (or Consulate) for the study visa (Application for X Visa is required of any applicant whose study time in China is over 6 months).
- 4. The student is required to register at International Office of Lanzhou University of Finance and Economics during the time specified in Admission Notice and apply for Residence Permit within 30 days after arriving in China. The student shall be fined by the local Public Security Bureau if he fails to do so within the said period.
